I, _____, undersigned is the Chief instructor of the above dojang. I would like to apply to be a member of Chan Hun Ryu ITF TaeKwon-Do Federation and as an affiliated dojang. In consideration of my application to be a member in your federation and in participation in the program as well as events, activities, competitions facilitated, sanctioned or organized by Chan Hun Ryu ITF TaeKwon-Do Federation, the applicant (as well all dojang's members that including in the case of a minor child- under 18 years of ages-, the parent or legal guardian, hereby freely, voluntarily and without duress executes this agreement under the terms below:

- 1- RELEASE AND WAIVER:** The Applicant (as well all dojang's members that including in the case of a minor child under 18 years of age, the parent or legal guardians and the applicant's heirs, executors, administrators, assigns and anyone else who may make a claim for or on behalf of the applicant (the Releasors) release, waive, discharge and covenant not to sue or commence any action against Chan Hun Ryu ITF TaeKwon-Do Federation, its employees, officers, directors, contractors, agents, volunteers, sponsors, event organizers and other person or organization assisting or involved in the Federation (the Releasee) from or for all liability, and waive against the Releasees all claims, demands, damages, actions, causes of action or any recourse whatsoever arising out of or in respect of any loss, personal injury or damage to property incurred from or arising out of or connected with the applicant's affiliation and participation in or attendance at the Federation activities, including travelling to and from such activities or resulting from any decision of any Releasees, notwithstanding any such loss, personal injury or damage to property that may have arisen by reason of the negligence of any Releasee.
- 2- INDEMNITY:** The applicant (all dojang related parties) and the Releasors agree to indemnify and hold harmless the Releasee from and against any liability, loss, damages, expenses, costs, claims, demands, actions or causes of action arising out of or in consequence of the applicant's participation in or attendance at the Federation activities, including traveling to and from such Activities or resulting from any decision of the Releasee.
- 3- ASSUMPTION OF RISK:** The applicant and its affiliated club members are in proper physical condition to participate in the Federation's activities. The applicant/ participants understands that the sport of Taekwon-do the ACTIVITIES ARE BY THEIR NATURE risky and hazardous, and accepts and assumes personal responsibility for those risks and hazards notwithstanding that any personal injury or loss of property which the applicant/participants may incur may be due to the negligence of any of the Releasee.
- 4- AFFILIATION FEES:** The Applicant will pay in full the Federation's affiliation fees set out by the Federation and acknowledges that such fee is not refundable, in the event the applicant is expelled from the Federation.
- 5- POLICIES AND SAFETY EQUIPMENT:** The applicant will observe strictly the policies, terms, conditions, rules and regulations of CHAN HUN RYU INTERNATIONAL TAEKWON-DO FEDERATION as communicated by its Headquarters.
